Propose to increase production by perforating additional interval 4106' - 4190' w/ 2 ISPF and acidizing perfs w/ 4000 gals 15% acid in two stages of 2000 gals each. The stages will be separated by 500 gallons gelled water containing 150 lbs crushed mothballs. Flush with 50 bbls lease crude. Acidize open hole section with 1000 gals acid and flush w/ 25 bbls water. Install pumping equipment and return to production.
