DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On July 12, 1948 at 4:00 P.M. 30 hours had elapsed since running 451' of 9-5/8" new casing in subject well and cementing with 300 sacks to be used as surface string. At this time casing shut off was tested as follows: A pressure of 750 # was built up and held for 30 minutes, tested OK. Cement plug was drilled and a pressure of 750 # again built up and held for 30 minutes. This test, too, was OK. Drilling operations were resumed.
