DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On July 11, 1952, the well reached a total depth of 4250'. 5 1/2" casing was set at 4242' and cemented with 700 sacks of cement by the two-stage method. 450 sacks of cement were used from total depth to 2450'. A DV tool was set in the Rustler formation at 1580' and cemented with 250 sacks of cement. The 5 1/2" casing was tested with 1000# of surface pressure and 9.6# mud. The 5 1/2" casing was allowed to set 72 hours before completion practices were exercised, on the approval of Mr. Yarbrough, State Oil and Gas Inspector.

## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On June 14, 8-5/8" casing was run to 360' and cemented with 300 sacks of neat cement. Cement was allowed to set 24 hours and casing was tested for 30 minutes with no drop in pressure. Drilling operations were then resumed on the approval of Mr. Yarbrough, State Oil and Gas Inspector.
