DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Supplemental report of work performed and subsequent results are as follows:

Cleaned out to total depth. Ran 4196' of new 5 1/2" casing set at 4174 and cemented in two stages. 1st stage 100 sacks neat cement. 2nd stage: 450 sacks cement mixed, 8% gel, with staging tool set at 3874. Perforated intervals 4110' - 4144', 4158' - 4168' with 4 shots per foot. Washed with 500 gallons 15% regular. Acidized with 4000 gallons 15% regular. On Potential Test flowed 59 BO, 19 BW in 24 hours. GOR 1590. Estimated Allowable 39 BOPD effective 10/22/54.
