At 6:00 AM April 19, 1937 72 hours had elapsed at which time we tested 7" OD new casing set at 4068 and cemented with 350 sax.

We conducted the test in the following manner; built up 1200# on casing closed valves and held for 30 minutes, tested OK; drilled plug, built up 1200# closed valves and held for 30 minutes, tested OK.
