It is now proposed to Plug and abandon well no. 75-6000'. Spot 75 at cement plug set at 6442' and 4 1/2' cement (PBD 6442') to lower fluid levels 510-5200 and back up to 6000. Cut & pull 7" pipe from point (TENT 3472). Cut & pull 4 1/2" at same point (TENT 412). Spot 25 at plug in cut of 4 1/2" and 10' at surface, well P.A. makes.

It is now proposed to plug and abandon well no. 75-6000'.
