

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

The above well was drilled to a total depth of 8021' where the Devonian formation was tested and found to be commercially unproductive. Therefore, we hereby request permission to plug-back to a depth of 7560' with 300 sacks of sulphur resistant cement in order that the Brinkard formation may be tested further.

After testing the plug for hardness, 7" casing is to be set at approximately 7300 feet and cemented with 500 sacks.
