Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were grown in the medium containing 100 mg/l of tetracycline. The cell concentration of the *Agrobacterium* strains was adjusted to 100 mg/ml. The cell suspension was mixed with the plant tissue and the transformation efficiency was determined. The results are shown as the mean \pm SD of three independent experiments. The asterisk indicates a significant difference ($p < 0.05$) between the two groups.
