6-24-86 Cleaned out cellar and discovered 9 5/8" int. csg. clamped and setting on 12 1/2" surface csg. stub. Ram 13 ft of 1/2" standard API line pipe (1" would not go) through one side of clamp into 12 1/2"-9 5/8" annulus and extended pipe out of cellar above G.L. Sealed both small openings to annulus through the clamp and built forms around csg. and clamp. Cemented line pipe in place sealing the annulus so surface csg. pressure readings may be taken as needed.
