12 1/2" 40# 8-Thd. New Lapweld casing was set in this well at 201' and cemented with 200 sacks by the Halliburton Method

Cement was drilled out of casing and the hole bailed dry and then allowed to stand undisturbed for one hour. The bailer was again run to bottom to determine if any water had accumulated. No water had accumulated so the drilling was then resumed.
