Ran 8 Jts (254') 13-3/8" OD 48# Gr H-40 SS casing. Set and cemented at 269' with 375 sacks Regular Best cement. Plug at 249'. Maximum pressure 200#. Circulated approximately 40 sacks cement. Job complete by Hovee 3:PM 12-31-54.

After waiting over 24 hours, tested 13-3/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 249' to 269'. Tested below casing shoe with 350# for 30 minutes. No drop in pressure.
