We propose to drill above location to a depth of 3750' with cable tools or deep enough to test Seven Rivers. 13 3/8" casing will be cemented at 70', cement circulated. 8 5/8" casing set in anhydrite at approximately 1500', cemented to surface. 5 1/2" or 7" casing to be set through salt section with 50 sacks cement. If productive, 5 1/2" or 7" casing cemented back to surface.

\* The U. S. G. S. being notified in sufficient time to witness all cementing and testing operations.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.


