Moved rig off and rigged up pulling unit. Tested casing 1000 psi. for 30 minutes, no decrease in psr. Perforated 7860-63, 7865-67. Acidizing w/500 gals. swbed, salt water, light show gas & oil. Set bridge plug @7765'. Perforated 7709-19, 7722-29, 7680-84 & 7627-38 & acidized w/1500 gals. acid treating individual zone by pkr. & retrievable treating tool. Swabbed all zones recovering salt water w/ slight show oil. Prep. to recover casing and P. & A.**


