FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Perforations 13,766°-13,774° and 13,714°-13,730° have already been plugged with cement in re-completion attempt. Perforations 13,659"-13,675" are shut off with Baker Model "D" packer with "DR" plug installed set at 13,628%.

Perforations 13,552"-13,566' will be plugged with 25 sack plug from 13,550"-13,452". 7" casing will be shot off and pulled from free point somewhere above 13,288". 25 sack cement plug will be placed in the 7" casing stub. 25 sack cement plug will be placed in the top of the Bone Spring at 8350°. 25 sack plugs will be placed in the base of the 9 5/8" casing at 5498°, the stub of the 9 5/8" wherever shot off, and the base of the 13 3/8" casing at 894°. A 10 sack plug with the proper marker will be placed in the top of the 13 3/8" casing.
