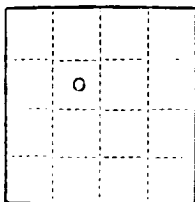

Spudded 1-1-63 and drilled to 871'. Ran 20 joints of 13 3/8", 148#, H-40 casing to 854'. Cemented by Halliburton with 800 sacks Trinity regular with 2% gel, 2% CaCl₂, and 1/4# Flocele per sack. Found top of cement at 805'. W.O.C. 2 1/2 hours. Tested casing with 1000# for 30 minutes, held OK. Circulated
