Drilled to 4215' - set 5 1/2" 15.5 lb/gal cemented with 300 sacks. Tested csg. 1000' for 1 hour after setting 48 hrs. Reverse mud out with oil - perforated 4173-4210. Acidized with 6,000 gallons inhibited acid and ball sealers, treatment pressure from vacuum to 1200 psi. Ran Western Gamma Ray Neutron Log. Install pump.
