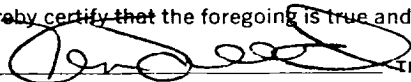
1. Set CIBP at 9490' and dump bail 35' of cement on top of CIBP.
2. Cut off 4-1/2" casing at 9000'±. Pull 4-1/2" casing.
3. Trip in hole with 2-3/8" tubing. Circulate hole with 9.5 lb./gal. mud.
4. Spot 100' plug 50' in & 50' out of 4-1/2 cut off @ 9000' (i.e. 8950 to 9050) using 25 sx. cement.
5. Spot 100' plug @ 8-5/8" csg. shoe 5025 to 5125 using 30 sx. cement.
6. Cut & pull 8-5/8" csg. @ approx. 2000'.
