Pulled rods, pump and tbq. Set bridge plug at 4037' & pump tested 5" liner perf. 3996' to 4018'. Re-set bridge plug at 3946'. Perf. 5" liner opposite G/SA zone w/2SPF at 3903', 3910', 3914', 3921', 3925', 3933', & 3937'. Swab tested, Pump tested. Pulled rods, pump & tbq. Recovered bridge plug, re-ran tbq., pump & rods & resumed pumping from 5" liner perf. 3903' to 3937', 3952' to 3961', 3996' to 4018' & from 4041' to 4049'.

Test of 6-27-78: Pumped 6 b.o. & 120 b.w. in 24 hours.
