Gentlemen:

On April 5, 1979, I completed my Wilson State No. 1 well as a gas producer in the Eumont Pool from the Yates formation between 3851 - 3938. The subject well is located 1650 FNL and 2310 FWL Section 32, T-20-S, R-36-E, Lea County, New Mexico. Since the total acreage dedicated to the subject well is less than the prescribed 640-acre spacing for the Eumont (Gas) Pool, I am requesting that the NMOCC approve a 280-acre non-standard proration unit for the subject well consisting of the NW/4 NW/4, S/2 NW/4, and SW/4 Section 32.

Furthermore, as indicated on the attached plat, the Wilson State No. 1 was drilled as a wildcat test to the Queen formation with the wellsite being located at the highest structural position on the designated 280-acre proration unit. Because the new wellsite is classified by the NMOCC to be a non-standard gas location, I also wish to request at this time approval from the NMOCC for a non-standard Eumont (Gas) location for my Wilson State No. 1.

Three copies of a plat showing the location of my well and the outline of the proposed spacing unit are enclosed.

Copies of this application and plat have also been sent by certified mail to all offsetting operators owning shallow gas rights. A list of these operators is as follows:


