RE: Application to:

- (1) Vacate Administrative Order NSP-1643(SD)(L) which provides for a 160-acre NSPU for Eumont gas production in the SE/4 Sec. 12, T-19S, R-36E dedicated to Conoco's State KN-12 Wells No. 3 & 7
- (2) Reinstate Hearing Order No. R-6355 which provided for a 120-acre NSPU for Eumont gas production in the NE/4 SE/4 & S/2 SE/4 Sec. 12, T-19S, R-36E dedicated to Conoco's State KN-12 Well No. 7 only

Dear Mr. Stogner:

EXHIBIT A is a map of Conoco's State KN-12 Lease consisting of the S/2 of Sec. 12, T-19S, R-36E. Outlined on this map is the 160-acre NSPU in the SE/4 that is currently dedication to Wells No. 3 and 7. Also shown are the offset operators to this spacing unit.

Order No. R-6355, which was issued May 22, 1980, created a 120-acre NSPU for Eumont gas production dedicated to Conoco's State KN-12 No. 7. A copy of this original order is attached as EXHIBIT B.

On February 18, 1992, this spacing unit was enlarged to 160 acres and simultaneously dedicated to Eumont gas production from Wells No. 3 and 7 by placing Order No. R-6355 in abeyance and issuing Administrative Order NSP-1643(SD)(L). A copy of this order is attached as EXHIBIT C.

The State KN-12 NO. 3 has recently been reclassified as an oil well in the Eumont Pool and must be separated from simultaneous dedication with Well No. 7. Therefore, it is requested that the Administrative Order NSP-1643(SD)(L) be vacated and the original Hearing Order R-6355 be reinstated.

This action would separate out the 40 acres required for dedication to the No. 3 oil well and leave the remaining 120 acres dedicated to the No. 7 gas well. Copies of this application have been sent by certified mail to all offset operators and copies of the certified mail receipts are attached as EXHIBIT D. new C-102's are also enclosed reflecting this proposed action.





IN THE MATTER OF THE HEARING CALLED BY THE OIL CONSERVATION DIVISION FOR THE PURPOSE OF CONSIDERING:

CASE NO. 6888 Order No. R-6355

APPLICATION OF CONOCO INC. FOR A NON-STANDARD PRORATION UNIT AND AN UNORTHODOX GAS WELL LOCATION, LEA COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on May 7, 1980, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 22nd day of May, 1980, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Conoco Inc., seeks approval of a 120-acre non-standard gas proration unit comprising the S/2 SE/4 and NE/4 SE/4 of Section 12, Township 19 South, Range 36 East, NMPM, Eumont Gas Pool, Lea County, New Mexico, to be dedicated to its State KN-12 Well No. 7 drilled at an unorthodox location 330 feet from the South line and 1650 feet from the East line of said Section 12.
- (3) That the entire non-standard proration unit may reasonably be presumed productive of gas from the Eumont Gas Pool and that the entire non-standard gas proration unit can be efficiently and economically drained and developed by the aforesaid well.
- (4) That approval of the subject application will afford the applicant the opportunity to produce his just and equitable share of the gas in the Eumont Gas Pool, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number

of wells, and will otherwise prevent waste and protect correlative rights.

IT IS THEREFORE ORDERED:

- (1) That a 120-acre non-standard gas proration unit in the Eumont Gas Pool comprising the S/2 SE/4 and NE/4 SE/4 of Section 12, Township 19 South, Range 36 East, NMPM, Lea County, New Mexico, is hereby established and dedicated to its State KN-12 Well No. 7 drilled at an unorthodox location 330 feet from the South line and 1650 feet from the East line of said Section 12.
- (2) That jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.

Reference is made to your application dated December 17, 1991 for a 160-acre non-standard gas proration unit consisting of the following acreage in the Eumont Gas Pool:

LEA COUNTY, NEW MEXICO TOWNSHIP 19 SOUTH, RANGE 36 EAST, NMPM Section 12: SE/4

It is our understanding that this unit is to be simultaneously dedicated to your existing State KN-12 Well No. 3 located at a standard gas well location 1711 feet from the South line and 1677 feet from the East line (Unit J) of said Section 12 and to your existing State KN-12 Well No. 7 located at a previously authorized unorthodox gas well location (Division Order No. R-6355, dated May 22, 1980) 330 feet from the South line and 1650 feet from the East line (Unit O) of said Section 12.

By authority granted me under the provisions of Rule 2(a)4 of the Special Rules and Regulations for the Eumont Gas Pool, as promulgated by Division Order No. R-8170, as amended, you are hereby authorized to operate the above-described acreage as a non-standard gas proration unit, with allowable to be assigned thereto in accordance with Rules 5 and 8 of said pool rules based upon the unit size of 160-acres.


