Propose to perforate Zone II and acidize. MI and RUSU and pull injection tubing and packer. Run 3" casing gun and perforate from 4132-4160 with 4 JSPF. Run PPIP with 2 foot spacing and acidize from 4132-4160 with 2100 gallons of 20% NE HCL with additives. Pull packer to 3900' and flush with 30 bbls water. Run injection equipment and return to production. RD and MOSU.
