MI and RUSU 6-2-87 and pull 2-3/8" tubing and ESP. Dump 7-1/2 sacks sand down casing. Run collar locator by wireline and tag sand at 4223. Plug back with Calseal to 4207. Run PPIP with 2 ft spacing and acidize perms from 4188-4076 with 7200 gallons 20% NE HCL. Pull tubing and packer. Run ESP and 2-3/8" tubing to 4061. MOSU 6-5-87 and return to production.
