The subject well was spudded 11-29-85 with a 20" bit and drilled to 40'. Ran 14" conductor pipe (36.71') and set at 40'. Cemented with 3yds Redi-Mix. M1RU Cactus Right 67. Continuous drilling operation began 11-30-85. Drilled with a 12 1/4" bit to a TD of 1584'. Ran 8 5/8", 24", K-55 casing and set at 1584'. Cemented with 11005X class C cement with 1% CaCl. Circulated 2125X top it. WOC 18 hrs. Pressure tested casing 1000 psi for 30 mins - ok. Reduced bit to 7 7/8" and resumed drilling.
