Production to the tank battery started 11-1-88. However, low production of 1 to 3 BOPD with fluid level tests showing the well to be pumped off, indicated the possibility of a water block restricting production.

On 11-12-88, 30 gals of Halliburton HyFlo chemical mixed in 90 Bbls of crude oil was displaced down tubing with 10 bbls of crude oil (total of 100 bbls of purchased crude) with a packer set at 3500'. Shut well in overnight. Pull packer. Re-run tubing, pump and sucker rods. Start well to pumping 11-14-88.

## Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either now shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
