**Reclassification of Well**  
**Eumont Pool**  
**State A-3 Gas Com #2-0**  
**Sec. 3, T-20S, R-37E**

A Gas-Oil Ratio Test submitted to your office for the subject well, dated April 21, 1991, resulted in the reclassification of this well from gas to oil. Your letter of June 14, 1991 indicated this reclassification would be effective July 1.

This well was only recently drilled and completed. March, 1991, was the first full month of production. Although it produced initially as a dry gas well, this well recently began occasionally slugging some fluid and finally loaded up. We are presently swabbing the well and believe that it will return to gas status soon.

As per Evelyn Downs suggestion, we are requesting a 60-day extension of the gas allowable for this well to give adequate time for the true status of the well to be determined. In that length of time we should be able to determine where the GOR is going stabilize and avoid unnecessary reclassification.

Gentlemen:

According to the recently submitted gas/oil ratio test, the above-referenced well will be reclassified from a gas well to an oil well in the Eumont Pool effective July 1, 1991, and the gas allowable cancelled effective that date.

Please file a revised acreage dedication plat, Form C-102, showing 40 acres dedicated to this oil well classification. Also, file Form C-104 showing casing-head gas gather instead of dry gas gather.
