Ran 28 jts, 7", 20#, K-55, 8Rd new csg to 1228', float shoe @ 1226', float collar @ 1172'. Mixed & pumped 125 sx "C" w/ 6% gel, 2% CaCl₂, 1/4 pps cello @ 12.7 ppg, 1.86 y. Tailed in w/ 50 sx Class "H" thixad, 12% @ 12.7 ppg, 2.18 y. 2nd tail -150 sx "C" w/ 2% CaCl₂ @ 14.8 ppg, 1.34 yield. Bumped plug w/ 1000 psi. CIP @ 1500 hrs 11-12-94. Circ'd 111 sx. WOC 4 hrs. Cut csg. Installed 7" SOW x 9" 3M csg head. NU 9" 3M Shaffer dual ram BOP. Tested choke manifold, lines, pipe & blind rams, mud lines & floor valves to 3000 psi. PU BHA & tagged cmt @ 1122', total WOC time - 18 hrs. Drld cmt & FC to 1202'. Tested csg to 1500 psi. Drld cmt, shoe, & formation to 1233'. Ran PIT test to 12.04 ppg EMW. Drld 6-1/8" hole to 3760'. Plug down @ 2030 hrs 11-19-94. Circ'd 25 sx. ND BOP. Set 4-1/2" slips w/ 40k. Cut csg. Installed 9" 3M x 7-1/16" 3M tbg head & tested to 1200 psi. Rig released @ 0200 hrs 11-20-94.
