- 08/05/98 Move in, hold safety meeting, rig up, put on BOP, pull tubing, run bit and scraper, pull out of hole, shut down.
- 08/06/98 Run cast iron bridge plug, set at 3200', circulate mud, spot 25 sacks on top, circulate 3200' - 2950', pull to 2400', spot 25 sacks 2400' - 2150', pull to 565', spot 25 sacks 565' - 315', pull to 120', circulate 15 sacks to surface, cut off wellhead, put in marker, rig down.
