9/7/95 - Run pump in tracer and found water coming from 3312'. Squeeze existing perfs w/ 200 SX "C" cement to 3500 PSI.

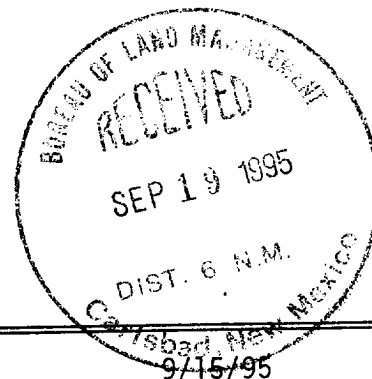
