- 2.) Run in hole with 4" Hogs gun, 2 JSPF, 180 degree phase & perforated the upper abo as follows: 6971', - 77' - 82' - 88' - 94' & 98'.
- 3.) Acidized perfs. with 360 bbls. of 20% Hcl acid, with an avg. rate of 15 BPM and avg. 3900 p.s.i.; I.S.I.P. - 2900 P.S.I.
- 4.) Run in hole & tst. tubing to 6000#/ok.
- 5.) Retrieved R.B.P.
- 6.) Run in hole with Baker Model R-1 Production packer and set at 6875', removed B.O.P, cont. to swab for load recovery and return to production.
