Spudded well on 2/17/02 @ 19:00 CST. Drilled 12-1/4" hole to 1416'. On 2/18/02 ran 33 jts. of 8-5/8" 24# J55 STC casing (set @ 1416'). Cement w/20 bbls F/W ahead. Lead w/440 sx Class "C" Lite + 6 pps salt + 0.25 pps Flocele (12.5 ppg, yield 2.06). Tail w/200 sx Class C + 2% CaCl<sub>2</sub>(14.8 ppg, yield 1.34). Displace w/88 bbls brine. Bump plug w/500# over (foot ok). Circulate 128 sx to pit.

Test blind rams to 1000 psi.
