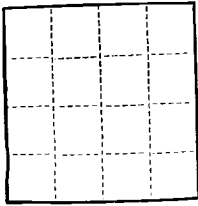

DETAILS OF WORK

We propose to drill to a total depth of approximately 5200 feet with rotary tools and complete in the Delaware formation. The casing program will be as follows: 8-5/8 inch 20#, H-40 surface casing to be set @ 1400 feet and cemented with 150 sacks. Cement will be circulated to surface. 4-1/2 inch 11.60#, J-55 casing set @ 5100 feet and cemented with 175 sacks cement. Bond sent to Santa Fe.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
