On 1-2-60, this well flowed 2 BOPD, no water with 1008 MCFGPD, GOR 504,000 through an open choke. The well was classified as a gas well on 1-21-60. The well is now shut-in.

It is proposed to cleanout this well and lower the packer in order to reduce the GOR and return the well to producing status.

Permission is requested to perform this work.

A subsequent report will be submitted upon completion of this work.
