DETAILS OF WORK

It is our intention to drill a well at the above location to a total depth of approximately 3850' with rotary tools in order to continue development of the Queen oil reserves under the subject lease. All casing points will be cemented in accordance with approved methods of the U. S. Geological Survey and any other special requirements will be complied with.

It is planned to use the following casing patterns: 8 5/8" to be set at 300' and cemented with approximately 250 sacks, cement to be circulated. 5 1/2" to be set at 3850' and cemented with approximately 1100 sacks, and to be perforated opposite the pay zone.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
