Texaco proposes to do the following work on subject well:

1. Pull production rods and pump.
2. Cut bull plug off Drinkard string.
3. Run thru-tubing perforating gun and perforate w/2 JSPF from 6850'-6857', 6863'-6866', 6872', 6877'-6882'.
4. Acidize down 2-3/8" Drinkard tubing w/6000 gals. 15% acid in six equal stages. Follow first three stages w/65# 50/50 mixture unibeads and minibeads and next two stages w/35# 50/50 mixture unibeads and minibeads.
5. Swab, test and return to production.
