Re: Continental Oil Company's Application for Administrative Approval of the Dual Completion of the Britt B-15 No. 11 in the Weir and Weir-Tubb Pools, Section 15, T-20S, R-37E, Lea County, New Mexico.

We are attaching two copies of Continental Oil Company's Application for Administrative Approval of the dual completion of the Britt B-15 No. 11 for Drinkard Oil in the Weir Pool and Tubb oil in the Weir-Tubb Pool. The well is to be located 1980' FWL & 660' FSL of Section 15, T-20S, R-37E, Lea County, New Mexico.

The well is proposed for drilling on acreage within the 160-acre non-standard gas proration unit for Tubb gas assigned the Britt B-15 No. 9. The following is the reason for the selection of this well location.

The Britt B-15 No. 9, located 1980' FSL & FEL of Section 15, was the discovery well in the Weir-Tubb Pool. The well was completed for a calculated open flow potential of 14,600 MCF gas per day on April 23, 1959.

Further development of the Tubb formation in the area included drilling the Britt B-15 No. 10 at a location 1980' FNL & FWL of Section 15. Approval of a 160-acre non-standard gas proration unit for this well in the Weir-Tubb Pool was granted by Order No. R-1502. However, the well was completed as a flowing oil well with an initial potential of 756 BOPD, no water, and a gas-oil ratio of 1057 to 1. Consequently, NSP Order No. R-1502 was cancelled.

Due to the dissimilarity of production from the Britt B-15 Nos. 9 and 10, which are located on diagonally offsetting locations, we cannot at this time discern the true limits of gas and oil production from the Tubb formation. The proposed additional development of the area will help define these limits. This development will be followed using step-out locations. The Britt B-15 No. 11 is proposed for drilling on a southwest diagonal location to the Britt B-15 No. 9. Upon completion of the well, an application for acreage rededication will be submitted which will be dependent upon the type completion obtained from the Tubb formation in the well.

We therefore respectfully request administrative approval of the dual completion of the Britt B-15 No. 11 at a location 1980' FNL and 660' FSL of Section 15, T-20S, R-37E.
