Order No. MC-1190 authorized the completion of our Britt B-15 No. 13 as an oil-oil dual in the Weir Blinebry and Monument-Tubb Pools. Contrary to expectations, the Tubb formation was found to be gas productive.

Your Hobbs Office has advised that the order must be amended to secure approval of this change of conditions. Therefore, we are forwarding herewith revised applications in duplicate showing the data on the completed zones. The schematic diagram has been revised to show actual depths and conditions. The log, which was not available at the time of filing the original application, is also attached. The plat, attached to the original application, is still applicable.
