The SEM Pennsylvania is presently TSD. An attempt was made on July 3, 1962, to fish the pump from this well. During the process, the 7" casing WAS FOUND TO BE parted in two or more places. We propose to remove approximately 2800' of existing casing by cutting, fishing and milling. It will then be replaced with 7" OD 23# J-55 casing utilizing a casing bowl.
