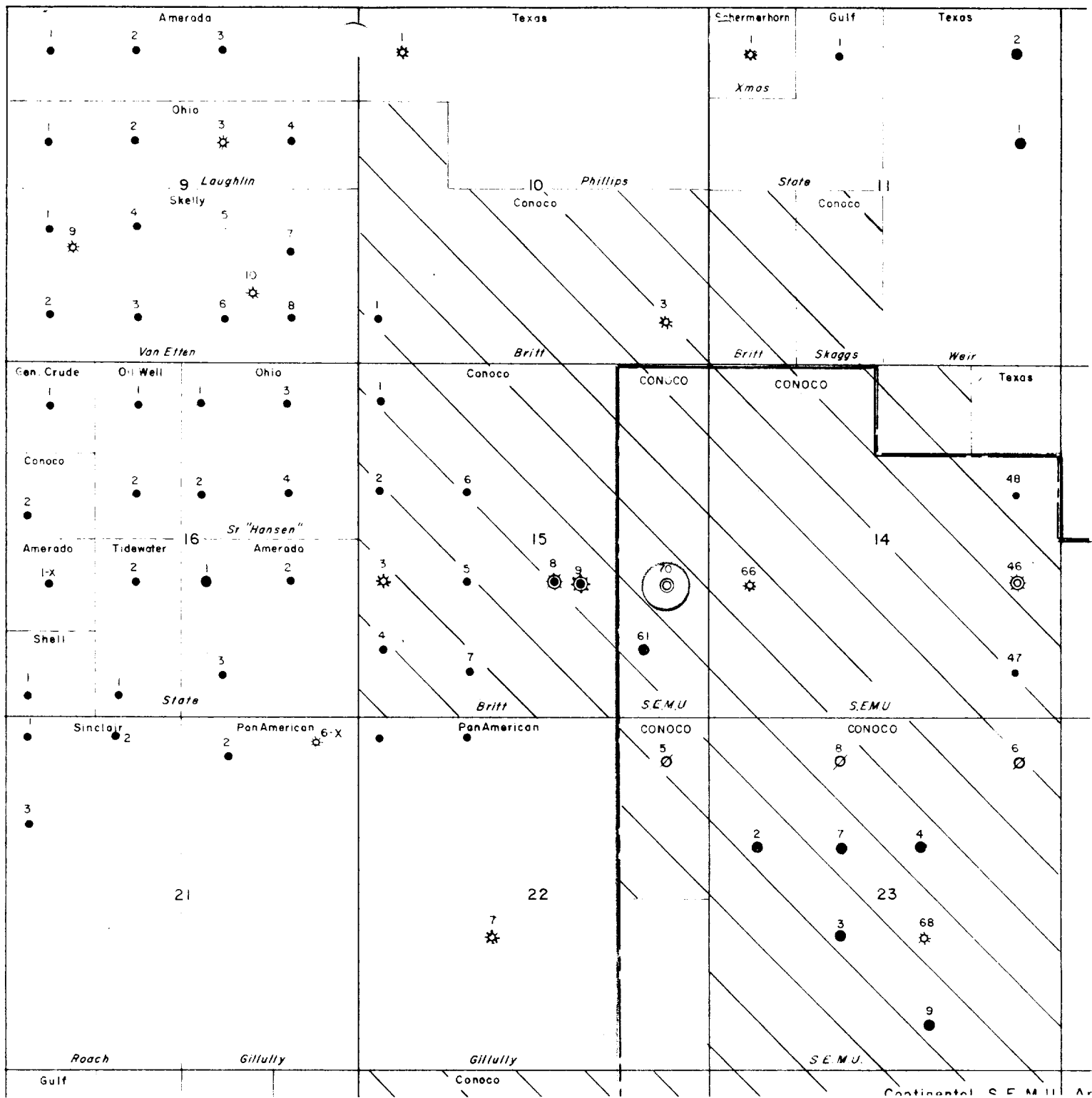

Continental Acreage Cross-Hatched

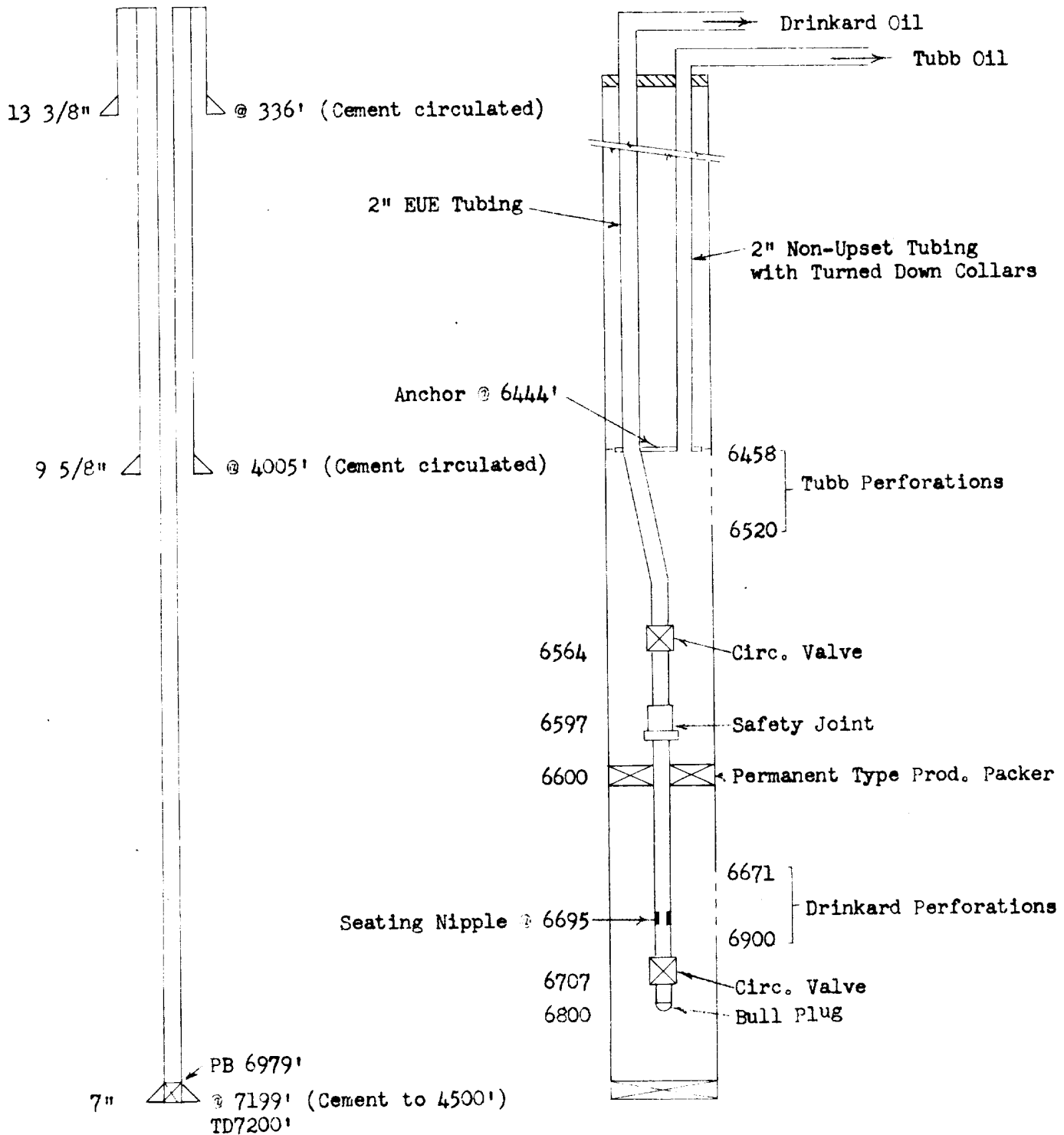
