(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Pull rods and tubing, run Gamma Ray Neutron-Camoton logs, set a cast iron retainer at approximately 3775' and squeeze 4-3/4" open hole from 3782' to 3842' with 50 sacks incor cement. Perforate subject to logs, approx. 10', with 2 bullets per foot and swab natural. If necessary, fracture with 10,000 gallons crude oil, sand and walnut hulls. Swab and resume production
