Ran gauge ring to check casing. Set Baker bridge plug at 3510'. Dumped 50 ft cement on top of plug. PB depth 3460. Tested surface and intermediate casing for pressure. Filled casing with mud and tested 5 1/2" casing with 1000#.

Pipe and head were not removed from the well.  
The well has been temporarily plugged and abandoned.

A Form C-103, approved by NMOCC 6-19-61, specified that the status and future plans for this well must be reported every 6 months. At this time we have no plans to alter the status of this well. Another Form C-103 will be filed in June, 1962, unless we develop additional plans prior to the filing.


