4. *Staphylococcus aureus* (ATCC 12228) was grown in tryptic soy broth (TSB) (Difco) supplemented with 0.5% yeast extract (Difco) and 0.5% glucose (Difco) at 37°C. Cells were harvested by centrifugation at 10,000g for 10 min and washed with distilled water. Cells were resuspended in distilled water and then lysed by sonication. The cell debris was removed by centrifugation at 10,000g for 10 min. The supernatant was then dialyzed into distilled water and concentrated by ultrafiltration (Amicon, Beverly, MA, USA).
