If changes in the above plan become advisable we will notify you before cementing or landing casing. We estimate that the first productive oil or gas sand should occur at a depth of about 3800' feet.

Additional information: 13"OD Casing will be cemented w/sufficient cement to reach back to surface. 9-5/8"OD Casing will be set at top of salt and will be cemented at least 10' above bottom of 13"OD Casing. 7"OD Casing will be cemented with 150% of the calculated amount of cement to cement back to base of salt.
