FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

During the past few months, the above well has needed repeated swabbing in order to maintain flow sufficient to make its allowed production. Permission is therefore requested to install flow valves and connect outside gas for gas lift. The outside gas will be from Gulf's Eunice Gas System. The Eunice Gas System receives gas from our W.A. Ramsay #1 gas well, SW/4 of 34, 21S, 37E, producing from the Yates and Seven Rivers zones; from the H.T. Mattern #1 gas well, SE/4 of 24, 21S, 36E, producing from the Queen and Grayburg zones; from the B. Whitmire #4 gas well, NE/4 of 8, 20S, 37E, producing from the Grayburg and Eunice Dolomite zones; and from the Janda "B" #1 gas well, SE/4 of 32, 21S, 36E, producing from the Yates zone.
