FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production it is proposed to squeeze cement, perforate and acid treat as follows:

1. Pull tubing.
2. Set cement retainer on wire line at 3756'. Run tubing with stinger.
3. Squeeze cement open hole below retainer. WOC.
4. Perforate 5-1/2" casing from 3748-3725' with 4, 1/2" jet holes per foot.
5. Run 2-3/8" tubing with packer; if warranted acid treat with 250 gallons 15% NE acid.
