FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Intended Procedure: It is proposed to acid treat the well according to the following procedure: 1) Rig up, pull rods and tubing, 2) Run 2-inch tubing with Baker retrievable packer, 3) Spot gel on formation, 4) Pick up tubing approximately 15 feet and treat well with 5,000 gallons low tension acid, 5) Swab out acid load and test, 6) Pull tubing and packers and rerun rods and tubing, 7) Tear down and place well on production. Present production 6.05 barrels per day.
