2. Squeeze cement the gas zone from 3740 to 3750 feet.
3. Clean out to bottom and cement a liner in the open hole.
4. Perforate with 1 jet shot each at 3787 and 3805.
5. Frac with 10,000 gallons oil and 10,000# sand.
