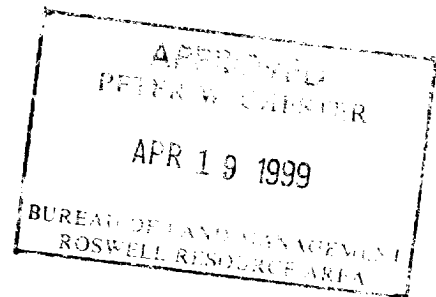

Plugging this well now may result in a premature abandonment resulting in lost Eumont reserves. A casing integrity test is being conducted during the week of March 29 to April 3, 1999.
