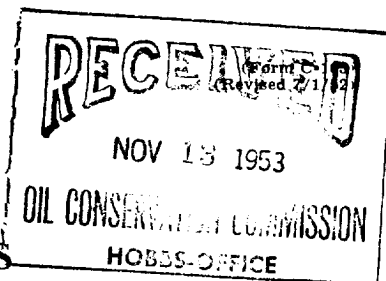

Installed Cabot AC 11E 80 D Unit w/15 HP Electric Motor. Ran 123 jts 3821' of tubing. Tubing set at 3826', seating nipple 3810', perforations at 3811-3815'. Ran Pump & Rods.

Pumped on Oil Conservation Commission test 33 bbls oil, 2 bbls water thru 2-3/8" tubing in 24 hrs 1-1/2" bore pump 14 x 42 spm. Gas Volume 27,800 cu. ft. GOR 843. Allowable before equipment installation 10 BOPD. Allowable after equipment installation 33 BOPD.
