Pulled and ran 2-5/8" OD EUE S.S. tubing, set at 3639', 95' of 3-1/2" Reg. S.S. tubing as collecting chamber from 3639 to 3739', 4-1/2" OD Lane Wells Production Type packer set at 3643'. 3725# valve set at 3629', 475# valve set at 2970'. Maria Intermittent gas lift system.

Production before: 18 oil, 2 water, necessary to shut well in to pressure up.

Production after: 23 oil, 2 water, through 2" wide open, gas from Eunice Gas System being intermitted 1-1/2 minutes every 30 minutes.
