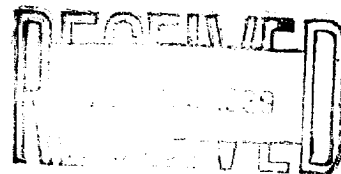

After acid well flowed 27 barrels of oil in 24 hours thru a 3/4" choke with 100# tubing pressure and 450# casing pressure. 1.4% BS&W.
